The Tamilnadu Pollution Control Board after examining the application, hereby certifies that M/s SRI PON POLYMERS, SF.No. 302/1A1, VISHVANATHAM Village, SIVAKASI Taluk, Virudhunagar District has been registered as a unit under Plastic Waste Management Rules, 2016 as amended in 2018 for manufacturing.

This certificate of registration shall be valid for the period up to 31/03/2026 unless revoked or suspended.

The certificate is granted subject to the following conditions:

1. The unit shall not manufacture, stock, distribute or sell any carry bags irrespective of thickness made of virgin or recycled plastics.
2. The unit shall adhere with all the conditions mentioned in the Plastic Waste Management Rules, 2016 as amended in 2018.
3. The unit shall ensure that multilayered packaging shall have name and Registration number of the Manufacturer.
4. The unit shall ensure that each compostable plastic carry bag shall have name, registration number of the manufacturer and thickness of each bag and also certificate number obtained from CPCB.
5. Each carry bag made from compostable plastics shall have a label "compostable" and shall conform to the Indian Standard: IS or ISO 17088:2008 title as specifications for "Compostable Plastics".
6. The unit shall ensure that plastic sheet or like/cover made of plastic sheet shall have the name of the manufacturer, registration number of the manufacturer, thickness of plastic sheet/cover and usage purpose of the plastic sheet/cover.

7. The unit shall ensure that plastic sheet or like/cover made of plastic sheet used for packaging, wrapping the commodity shall not be less than fifty microns in thickness except where the thickness of such plastic sheets impair the functionality of the product.
8. The unit shall ensure that the plastic material shall not be used in any package for packing gutkha,pan masala and tobacco in all forms.
9. The unit shall provide QR code/bar coding for the compostable carry bags manufactured by them in order to prevent fake compostable carry bags.
10. The unit shall coordinate with UNDP to workout EPR inline with the proposed integrated model for the state of TN.
11. The Producer shall submit action plan for waste collection system based on EPR enclosed by the MAWS Dept at the time of recovery of Registration.
12. The unit shall furnish their production,distribution and retailer/sale point details every month to the District Environmental Engineer citing the Registration Number.

Additional conditions

1. The unit shall comply with all the provisions of PWM Rules 2016 and Guidelines issued from time to time by the Ministry of Environment, Forest & Climate Change or Central Pollution Control Board or TNPCB.
2. The unit shall obtain a certificate from the Central Pollution Control Board before marketing or selling.
3. The unit shall generate QR code based on the details provided in the certificate issued by CPCB and QR code shall be provided on each of the paper cup manufactured at the unit.
4. Each compostable paper cup shall bear a label “compostable” and shall conform to the Indian Standard: IS 17088:2008 titled as Specifications for Compostable Plastics, as amended from time to time.
5. Each compostable paper cup shall have the information regarding name and certificate number in accordance with 11(1) of PWM Rules.
6. The unit shall provide six-monthly report, giving details of raw material procurement and product sale to the Board.
7. The unit shall not undergo any expansion activity without prior consent of the Board.
8. The unit shall not invite any public complaints for its operation
9. The unit shall not manufacture any banned plastic products like “Plastic sheets/cling film used for food wrapping , Plastic sheets spreading on dining table, plastic thermocol, plate, plastic coated paper cups, plastic coated paper palates platic tea cups, plastic tumbler, thermocol cup, plastic coated carry bag of all size and thickness, Non oven carry bag of all size and thickness, water pouches, plastic straw, plastic flag, ear butts with plastic sticks , plastic sticks for balloon, candy with plastic sticks , ice cream plastic sticks , polystyrene for decoration, cutlery shuch as , plastic fokes , plastic spoon, plastic knife, packing or wrapping of sweet box invitation card, cigarette box, PVC banner less than 100 micron, plastic stirrers and plastic tray” as per Go(Ms) No.37 of Environment and Forest department dated.05.06.2020 and CPCB Direction No.B.17011/7/UPC-II-PWM(SUP)/2022 dated:30.06.2022.
10. The unit shall prepare and submit an annual report in Form-IV to the local body concerned under intimation to the concerned State Pollution Control Board by the 30th April, of every year.
